### CHEMTREC®

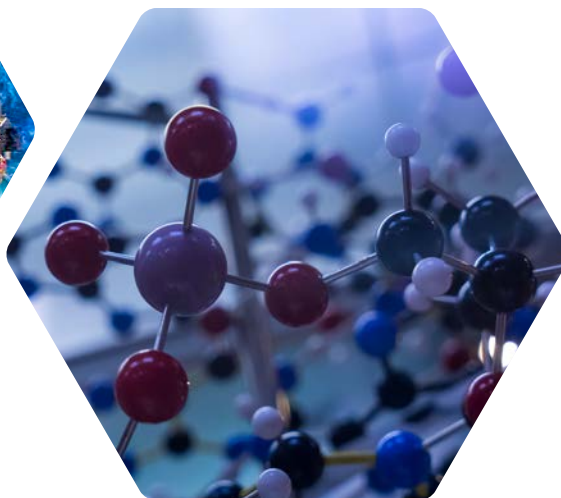
